

Summer 2018 Financial Aid Checklist and Application

To apply for financial aid for summer 2018, a student must:

- Complete the 2017-2018 Free Application for Federal Student Aid (FAFSA) by May 7, 2018.
- Submit the SCSU Summer 2018 Financial Aid Application by May 7, 2018. **(The application is required for both financial aid and alternative loans.)**
- Be officially accepted into a degree program by Undergraduate Admissions or the School of Graduate Studies.
- Register and maintain at least half-time enrollment during one or more of the summer sessions. (Half-time enrollment is a minimum 6 credits for undergraduate students and a minimum 4.5 credits for graduate students.)
- Register at least half-time by May 23, 2018.
- Maintain satisfactory academic progress. (Go to www.southernct.edu/financialaid for more information.)
- Review your Banner Web account for additional requirements.
- Complete the study abroad form, if applicable.

Please Note:

Budget ahead and have alternative funding available for costs not covered by financial aid and expenses not billed directly by the university. (Expenses not billed directly by the university include books, supplies, and off-campus room and board.)

Summer 2018 is considered part of the 2017-2018 academic year. Therefore, if you have borrowed the maximum annual loan amount for your grade level during the fall 2017 and spring 2018 semesters, you are not eligible for a Direct Loan (subsidized and/or unsubsidized) for the summer. I understand that I must meet all student eligibility criteria including, but not limited to, the following:
1) acceptance to the university as a matriculated student; 2) registered for half-time enrollment during one or more of the summer sessions (Half time for undergraduate students is a minimum 6 credit hours and graduate students is a minimum 4.5 credit hours); 3) submit a 2017-2018 FAFSA with the federal processor by May 7, 2018; and 4) submit the Summer 2018 Financial Aid Application by May 7, 2018.

I understand that as a financial aid (loans and grants) and/or alternative loan recipient I must register for all of my summer courses by May 23, 2018, to have my financial aid award or alternative loan credited toward my summer 2018 bill.

In addition, I understand that if the number of credits for which I registered changes, my financial aid and/or alternative loan may be adjusted or canceled accordingly. This could result in an outstanding bill with the university.

I understand payment is due at the time of registration. If my aid is not credited to my account or is not enough to cover the bill, I must make payment arrangements with Student Accounts or risk having my summer course schedule dropped for non-payment. I also understand I will be responsible for late fees and/or re-registration fees assessed by Student Accounts.
